## PARTICIPATION REGULATIONS

## The 3<sup>rd</sup> Carl R. Loper Conference on Processing of Metallic Materials through Casting and Solidification September 22-25, 2024, Brasov, Romania

- 1. The Organizers of the 3<sup>rd</sup> Carl R. Loper Conference (3rdCRLC) are:
  - the "Transilvania" University of Brasov, Faculty of Materials Science and Engineering (UniTBv),
  - Professor Doru M. Stefanescu (DMS)
  - Thomas Prucha, Editor in Chief International Journal of Metalcasting (IJMC)
  - the Romanian Foundry Technical Association (ATTR)
- 2. The conference language is English.
- 3. The condition for participation in the conference is registration by August 31, 2024, via the form available on the website of the conference: http://3rd-cr-loper-conference.unitby.ro/.
- 4. Conference registration includes a few categories of participants:
  - Speaker presenter of a paper, one person per paper
  - Speaker Student, MA, PhD presenter of a paper, one person per paper
  - Participant Standard participant in audience
  - Participant Student, MA, PhD participant in the audience
  - Accompanying person a family member or partner, non-participant to the scientific program of the conference.
- 5. The Participant who wants to present a paper at the conference must register through the registration form and provide the abstract at the e-mail address: <u>3rd-CR-Loper-Conference@unitbv.ro</u>. Information about abstract acceptance will be sent within 14 days from submission. The deadline for abstract submission is May 15<sup>th</sup>, 2024.
- 6. After abstract acceptance, the invoice will be prepared and sent to the participant by e-mail.
- Payments should be done by bank transfer to the ATTR account in maximum 10 days after receiving the invoice but not later than June 30<sup>th</sup>, 2024, without any claim for a refund in the case of absence of the person registered for the conference (see paragraph 12.b Conditions for resignation).
- 8. Applications for registration sent after September 1<sup>st</sup>, 2024 will not be considered.
- The condition for participation to the conference is that the full participation fee is credited to the account of ATTR no later by July 15<sup>th</sup>, 2024.
- 10. Accommodation is not included in the participation fee. Participants are required to individually book rooms in the hotel or agency recommended by the organizers. The conditions for booking rooms are specified by the hotel or agency. The organizers are not responsible for the rules formulated by the hotel or agency.

  - c. Lack of the full payment for participation is equal to resignation from participation in the conference.
  - d. It is allowed to change the person enlisted by September 10<sup>th</sup>, 2024, after informing the Organizers.
- 14. The Organizers reserve the right in the event of circumstances beyond their control, particularly the introduction of restrictions related to the epidemic of a dangerous infectious disease (i.e., COVID-19) or military conflict to change the conference formula to a remote or hybrid (stationary + remote).
